Throughout this two week-long virtual Expo, U.S. exporters will have the ability to schedule one-on-one virtual meetings with pre-screened overseas distributors, buyers, and multipliers. And vice-versa, foreign attendees will have access to reach out and schedule meeting with U.S. attendees. U.S. exporters can also request one-on-one meetings with U.S. embassy officials to gain insights into real-time market access.
