- November 2022: released final Program Guidelines and the Call for Projects for TIRCP cycle 6. The first tranche of funds for existing TIRCP projects leveraging federal and local funds was awarded on January 31, 2023. More than \$2.5 billion was awarded to 16 existing projects throughout California. The second tranche of funds for new TIRCP projects is set to be awarded by April 2023. Applications are due no later than February 10, 2023.

Lead the state's interagency workgroup to implement the federal IIJA transportation provisions which includes policy direction and funding in the areas of climate action, zero-emission vehicle deployment, social equity, and multi-modal transportation investment.

- d. **Port and Freight Infrastructure Program (PFIP).** Announced a \$1.2 billion one-time funding program to improve the capacity, safety, efficiency and resilience of goods movement to, from and through California's maritime ports, while also reducing public health impacts and negative economic impacts to communities adjacent to the corridors and facilities used for goods movement. Zero-emission goods movement demonstration projects are eligible for funding through the program.
 - October 2022: Released the program guidelines and Call for Projects. Awards are expected in Spring 2023.
