# **ECOSPIRITS**

ecoSPIRITS is a Singapore-based company that developed an innovative closed-loop distribution system that eliminates most of packaging waste in the premium spirits supply chain. ecoSPIRITS USA, the U.S. operating partner of ecoSPIRITS, recently announced the locations of its first ecoPLANTs in the U.S., one of which will be managed in partnership with <u>Chareau</u>, a distilled spirits plant operator Southern California. That new plant in Ventura went live just this year and will facilitate their partnerships with restaurants, bars, and hotels to help eliminate more than 95% of the packaging waste and 70–90% of carbon emission associated with premium spirits and wine supply chain in the region. Welcome to California!

Foreign Direct Investment in California, 2022 Report // World Trade Center LA (WTCLA), in partnership with GO-Biz and Loyola Marymount University, has released the seventh annual report on FDI in California. See the report to learn more about FDI trends by source country, sector, and county.

<u>California Business Investment Guide</u> // Compiled by the Governor's Office for Business and Economic Development (GO-Biz), this guide is intended to help businesses and for-profit entities identify relevant new and existing state funding resources for recovery and success.

<u>California Competes Tax Credit (CCTC) & Grant Program (CCGP)</u> // These tax credits and grants are available to businesses regardless of size, industry, or location. Businesses must create a minimum of 500 new full-time jobs, invest a minimum of \$10M in facility construction/renovation, and/or create jobs or make investments in an area of high unemployment and/or high poverty in order to be eligible. ~ California's top three export destinations were Mexico, Canada, China.

 $\sim$  California's top three import markets were China, Mexico, and Japan.

~ "Storm-battered February presented some unique challenges to California's exporters, many of them logistical in nature," said Jock O'Connell, Beacon Economics' International Trade Adviser." Apart from flooded farmlands and road closures, a fall-off in U.S. demand for imports led shipping lines to reduce service to West Coast ports, resulting in fewer ships available to carry exported goods."
