Grow your life sciences startup in California! The IncuStart Wet Labs and ReadyStart Cleanrooms by ThermoGenesis are set to open in the Summer of 2023 located in the Greater Sacramento area. The IncuStart Wet Labs will provide 26 rentable 6ft lab benches in over 2,000ft2 of co-

working space. Shared lab equipment includes Biosafety Cabinets, 160L Incubators, Centrifuges, along with shared cold and freezer storage. A separate cell culture room is available by reservation. Investment

<u>California Business Investment Guide</u> // Compiled by the Governor's Office for Business and Economic Development (GO-Biz), this guide is intended to help businesses and for-profit entities identify relevant new and existing state funding resources for recovery and success.

California Competes Tax Credit (CCTC) & Grant Program (CCGP) // These tax credits and grants are available to businesses regardless of size, industry, or location. Businesses must create a minimum of 500 new full–time jobs, invest a minimum of \$10M in facility construction/renovation, and/or create jobs or make investments in an area of high unemployment and/or high poverty in order to be eligible. The next application round will open on March 6, 2023. To learn more about how to draft a successful application, register for the March 16th webinar.
