Seminar: Private Sector Opportunities in Ukrainian Reconstruction

GO-Biz will support 14 California small businesses to exhibit in the California Pavilion at Farnborough International Airshow, which will be located in Hall 2. Grant funding from the State Trade Expansion Program (STEP) has been used to reduce the company participation fee to \$6,700 for STEP-eligible companies. This is a savings of over \$10,000 when compared to exhibiting individually in the smallest turnkey booth.

Businesses in the aerospace, aviation, and defense industries are invited to Farnborough for one of the world's premier airshows. Farnborough International Airshow aims to provide participants with opportunities to pioneer change, build new connections, engage with thought leaders, and access unparalleled business development opportunities. Aerospace and defense companies interested in expanding their international footprint are encouraged to apply.

GO-Biz is awarding up to 3 STEP-eligible California health and medical technology companies with \$5,000 in grant funding to offset exhibiting costs at Africa Health.

Africa Health will be held at the Cape Town International Convention Centre in South Africa. This show is the premier healthcare exhibition in the country, bringing together professionals, stakeholders, and decision-makers to share knowledge, showcase innovations, and tackle key sector challenges in the region. The show consists of diverse exhibitors spanning medical equipment, services, and technology as well as it features key workshops. In 2023, the show achieved \$131.1 million in business-generated revenue, making Africa Health a crucial networking and learning platform driving healthcare advancement across the continent.

ReBuild Ukraine

November 12–15, 2024 Warsaw, Poland

GO-Biz will support 10 California small businesses within the energy and construction sectors to exhibit in the California Pavilion at ReBuild Ukraine. STEP funding will be used to reduce company participation fees to \$3,500 for eligible businesses.

In its fourth year, ReBuild Ukraine is an international exhibition and conference that continues to be the premier offline platform for recovery projects, materials, technologies, equipment, and investments required to rebuild Ukraine's war-torn economy, with an emphasis on infrastructure, industry, energy, and housing. Receiving STEP funding includes additional incentives such as having access to business development matchmaking and consulting valued at \$3,000, an in-market business briefing on Ukraine and Poland, and a reception with Polish and Ukrainian business leaders. Non-STEP-eligible companies may participate at the full cost of \$8,000.

California Small Business Success Story



Air Quality Management Company (AQMC), founded and led by Ranyae Fernandes, is a California-based and women-owned business specializing in air and surface sterilization and odor removal through air-based methods. AQMC recently secured funding to facilitate its export endeavors in the Middle East and Europe. With the support of these funds, founder Ranyae has successfully obtained HVAC certifications vital for shipping to Middle East markets.

Ranyae has also collaborated closely with the U.S. Commercial Service and both European and Middle East companies to expand AQMC's global reach. Thanks to Ranyae's proactive efforts and assistance from the California STEP Grant, AQMC has now landed three significant projects in Saudi Arabia. These projects involve installations in the hospital, hospitality, and sewage treatment sectors, amounting to a total value of \$250,000.

Trade

State Trade Expansion Program (STEP)

The Governor's Office of Business and Economic Development (GO-Biz) administers the STEP grant program, which seeks to increase the number of small business exporters and increase the volume of goods and services they export. STEP helps small businesses to begin exporting or grow their existing export sales by providing reimbursable <u>Export Vouchers</u> and implementing <u>STEP Events</u>, which include organizing state pavilions at international trade shows and trade missions. <u>Visit the STEP website</u> or <u>contact Mariana Guevara</u> to learn more.

Western U.S. Agricultural Trade Association (WUSATA) FundMatch Program

California's membership in WUSATA allows qualified small food businesses the ability to expand

international marketing budgets for a variety of activities. The FundMatch program supports up to 50 percent reimbursement of promotional expenditures related to trade shows, labeling, advertising, retail promotions, and much more. <u>Visit the WUSATA website</u> or <u>contact Josh Eddy</u> to learn more.

Investment

California Competes Tax Credit (CCTC)

Tax credits are available to California businesses regardless of size, industry, or location. Businesses must create a minimum of 500 new full-time jobs, invest a minimum of \$10M in facility construction/renovation, and/or create jobs or make investments in an area of <u>high</u> <u>unemployment and/or high poverty</u> to be eligible. 


California's International Trade by the Numbers

Fast Facts: March 2024

- California's top three export destinations in March were Mexico, Canada, and China.
- California's top three import markets in March were China, Mexico, and South Korea.
- California's monthly exports in March 2024 decreased by 5.3 percent compared to 2023 and 9.8 percent compared to 2022.
- California's monthly imports in March 2024 decreased by 2.4 percent compared to 2023 and 22 percent compared to 2022.


