INTRODUCTION FROM THE WORLD TRADE CENTER LOS ANGELES

International trade and investment have never been more significant components of the economic landscape in California. The golden state's return to post-pandemic economic growth has been accompanied by a steady increase in foreign investment. This year 18,484 foreign owned enterprises (FOEs) accounted for 800,084 jobs across the state, an increase of 45,894 jobs from 2023, paying an estimated \$84.246 billion in wages to Californians. Despite a range of political and economic challenges both domestic and international, California maintains and entrenches its status as the world's gateway to the United States, and the United States' gateway to the world.

The annual 'Foreign Direct Investment in California' report serves as the premier source of insight into foreign direct investment (FDI) coming into the state from around the globe. In this ninth edition of the report, the World Trade Center Los Angeles (WTCLA) and the Institute for Applied Economics (IAE) – both entities within the Los Angeles County Economic Development Corporation (LAEDC) – have partnered with Loyola Marymount University's (LMU) prestigious Center for International Business Education (CIBE) to examine the distribution of investment throughout the state as well as provide a deeper understanding of the investment profiles of different clusters of FDI source countries and regions.

CIBE's analysis uses complementary metrics to group FDI source countries and regions into four profiles: titans, prospects, rising stars, and untapped horizons. These insights shed light on the underlying patterns affecting the spread and growth of investment across the state from the 24 largest sources of foreign investment. Complementing the report's overarching FDI source rankings, CIBE's analysis helps investors, governments, and businesses make more informed decisions for establishing and expanding their activity across California.

In developing this year's overarching rankings, IAE has adopted an improved methodology to provide increased accuracy of year-over-year comparisons and reliable employment estimates. Advanced analytical techniques were

used to identify trends and insights, ensuring the report's findings are robust and reflective of the true economic impact of FOEs in California. This included verification of each FOE's country of origin through their global ultimate business location, and cross-referencing multiple data sources to verify firms with the most substantial year-over-year growth. Additional targeted revisions include the exclusion of certain insurance firms and cruise lines where organizational structures and employee locations do not provide an accurate reflection of employment in California. This approach has been retroactively and consistently applied to data for 2022 and 2023 to develop the most robust picture of investment trends across all regions.

This year's findings present a fascinating and rich tapestry of investment across California. The United Kingdom (UK) has become the largest investor in the state by number of jobs, with UK FOEs accounting for 113,292 jobs in the state. However, Japan maintains a significant lead over the UK in terms of total FOEs present with 3,280, 69% more than the second placed UK. Despite a two-year decline in job numbers and FOEs, the UK is overtaking Japan due to significant growth in key sectors like professional services, hospitality, and technology. In contrast, Japan's modest job gains have been offset by declines in traditional industries like manufacturing and electronics, constraining its total jobs count. The picture across different California regions is highly diverse, with the five 'titan' investors – the UK, Japan, France, Canada, and Germany – ranking differently in each region, often accompanied by other countries breaking into a top five position in specific regions. Manufacturing continues to dominate as the largest industry sector for FOE employment, while professional and business services saw the highest raw increase in FOE jobs with 11,808 added this year. REGIONAL BREAKDOWN

This year's FDI report includes data on all of California to analyze the diversity and concentration of FOEs throughout the state. The breakdown into three distinct regions is illustrated in the adjacent map. Based on best practices and historical regional definitions, the Bay Area region's southern and northern boundaries are Monterey County and Sonoma County, respectively, with the eastern boundary formed by the counties Merced, Stanislaus and San Joaquin. Southern California includes all counties south of Monterey, Kings, Tulare and Inyo. Northern counties, parts of the Central Valley, and the mountainous counties on the Eastern border are considered Greater California.

AN ANALYSIS OF CALIFORNIA FDI PATTERNS: CLUSTERING FDI SOURCE COUNTRIES AND REGIONS

A special report from Loyola Marymount University's Center for International Business Education.

In this study, we develop an analytical framework to better understand the underlying patterns of foreign direct investment (FDI) in California. Our analysis reveals four distinct groups of FDI source countries and regions. The findings help local governments and business communities develop more targeted and effective policies and strategies customized for different FDI sources.


California is the investment destination for more than 100 foreign countries and regions. Those investments manifest various patterns in terms of location preference, industry focus, investment timing, and resource commitment. It is imperative for local governments and business communities to grasp such investment patterns to develop effective FDI-related policies and strategies. In this study, we propose six metrics to profile each FDI source's investment attributes and apply a clustering algorithm to identify the underlying patterns. The six metrics are:

- Investment amount, reflecting a source's economic significance and measured by a source's total number of foreign-owned establishments (FOEs) in California;
- Investment momentum, representing a source's most recent investment trend and measured by the percentage of the source's total FOEs created in the past five years;
- **Experience**, capturing a source's experience of operating in California and measured by the mean age of the source's FOEs;
- **Stability**, assessing a source's stability in making investments in California over the years;
- Industry coverage, evaluating the extent to which a source's FOEs fell into a diverse set of industries and creating opportunities for diverse populations;
- Location coverage, quantifying the extent to which a source's FOEs were distributed across a diverse set of locations and benefiting broader communities.








Figure 2d. Untapped Horizon

Based on these criteria, we identify four distinct groups of source countries and regions and visualize them by their investment amount and momentum (see Figure 1) . The first group, "Titans" (far right in Figure 1), includes the UK, France, Germany, Canada, and Japan. Despite a slower growth rate, this group of developed economies accounts for 56.7% of FOEs in California, leading the state's FDI in terms of operating experience, investment stability, location coverage, and industry coverage (see Figure 2a). Titans' FOEs are concentrated in retailing, wholesale trade, and manufacturing. The second group, called "Prospects" (in the middle of Figure 1), contains twenty-three source countries and regions. This group almost matches the Titans group in terms of business experience and industry coverage in California (see Figure 2b). Notably, among the Prospects, China and India are the two largest developing economies in the world. Mexico has become the largest trading partner of the U.S. since 2023, and Switzerland ranks sixth in total number of FOEs in California, only after the five Titans. These countries exhibit significant potential for FDI growth in California.

The third group, described as "Rising stars" (top-left in Figure 1), consists of Vietnam, Saudi Arabia, Bahrain, Poland, Mauritius, and Israel. Rising Stars are the countries that have shown the highest growth rate of new FOEs created in the past five years, indicating that investors from these countries are gaining momentum in their investments in California (See Figure 2c). Those investments focus on professional services, manufacturing, and retailing. If this trend continues, FOEs from those source countries will achieve a greater presence and could even join the Prospects group in the future. The fourth group, dubbed "Untapped Horizon" (bottom-left in Figure 1), comprises 19 countries but only accounts for 2.1% of FOEs in California. Interestingly, however, investors from this group have more business experience in California than the Rising Stars (See Figure 2d). Furthermore, some countries in this group, such as Norway and the United Arab Emirates, possess some of the largest sovereign wealth funds and manifest an investment momentum close to the Rising Stars.

In sum, our cluster analysis of California's FDI sources reveals foreign investors' distinct investment patterns. Profiling those patterns helps local governments and business communities develop more customized and effective policies and strategies to attract FDI and enables foreign investors to assess their investment status and make necessary changes to be more effective.


















