

GO-Biz administers the STEP grant program, which seeks to expand the number of small business exporters and increase the volume of goods and services they export.

STEP helps small businesses to begin exporting or grow their existing export sales by providing reimbursable <a href="Export Vouchers">Export Vouchers</a> and executing <a href="STEP Events">STEP Events</a>, which include organizing state pavilions at international trade shows and trade missions. #### FundMatch Program



The FundMatch program supports up to 50 percent reimbursement of promotional expenditures related to trade shows, labeling, advertising, retail promotions, and much more. #### Fast Facts: February 2025

- California's top three export destinations were Mexico, Canada, and Taiwan.
- California's top three import markets were China, Mexico, and Vietnam.
- California's monthly exports in February 2025 increased by 7.3 percent compared to 2024 and 9.5 percent compared to 2023.
- California's monthly imports in February 2025 increased by 2.4 percent compared to 2024 and 10.8 percent compared to 2023.
