INTRODUCTION FROM THE WORLD TRADE CENTER LOS ANGELES

As California takes its place as the fourth largest economy in the world in 2025, foreign investment continues to flow into the state. This year 18,963 foreign owned enterprises (FOEs) accounted for 814,102 jobs across the state – an increase of 14,018 jobs from 2024 – paying an estimated \$89bn in wages to Californians. As discussion of trade and investment becomes central both locally and globally, the value of international trade, investments, and partnerships is increasingly clear to the golden state. California is North America's largest trade nexus, its largest manufacturing hub and the most significant center for innovation in the world. The continued growth of investments in the state reflects its continued leadership in these fields, and the growing number of jobs supported by foreign-owned enterprises reflects the importance of these investments to California's economy.

The annual 'Foreign Direct Investment in California' report serves as the premier source of insight into foreign direct investment (FDI) coming into the state from around the globe. The World Trade Center Los Angeles (WTCLA) and the Institute of Applied Economics (IAE) – both entities within the Los Angeles County Economic Development Corporation (LAEDC) – have once again partnered with Loyola Marymount University's (LMU) prestigious Center for International Business Education (CIBE) to examine the distribution of investment throughout the state. This year, CIBE's special report on 'Revisiting and Reflecting on the California Business Environment' explores the relationship between affordability and productivity in California compared to other U.S. states, and the significance of California's unique diversification of industries. Complementing the report's overarching FDI source rankings, CIBE's analysis helps investors, governments, and businesses make more informed decisions for establishing and expanding their activity across California.

The 2025 report – launched on May 8th 2025 at the 10th Anniversary Select LA Investment Summit – expands the geographical analysis of previous versions. As well as the traditional regions examined – Southern California, Bay Area, Greater California – this year the data has been broken down by the 13 California Jobs First Districts. This

provides all Californians with significantly greater insights into the value of foreign investments to their local communities and the jobs they support. Additionally, data has been broken down by Los Angeles County Supervisorial district, Los Angeles County Congressional district, and City of Los Angeles Council district.

The United Kingdom remains California's top source of foreign-owned enterprise (FOE) employment in 2025, supporting 130,628 jobs across 2,215 establishments. This marks a net gain of over 17,000 jobs from the previous year, the largest year-over-year increase among all source countries and regions. UK investment is concentrated in high-wage, service-driven industries, with more than 43,000 jobs in professional and business services and 26,000 in manufacturing. Over 80,000 UK FOE jobs are located in Southern California, including 31,000 in Los Angeles County. Japan continues to rank second with 127,138 jobs and remains the state leader in FOE establishments with 3,391. While Japan added more than 14,000 jobs in 2025, its expansion remains concentrated in traditional industries, such as manufacturing and wholesale trade, which together account for more than half of Japanese FOE employment. Although Japan's overall footprint is broader, the United Kingdom's growth in service-based sectors reflects a shift in the composition of foreign investment toward higher-value and knowledge-based activities.

This year's report has been developed using improved methodology first adopted for the 2024 report. Advanced analytical techniques are used to identify trends and insights, ensuring the report's findings are robust and reflective of the true economic impact of FOEs in California. Each FOE's country or region of origin is verified through their global ultimate business location, cross-referenced with multiple data sources to verify firms with the most substantial year-over-year growth. Additional targeted revisions include the exclusion of certain insurance firms and cruise lines where organizational structures and employee locations do not provide an accurate reflection of employment in California. 



REVISITING AND REFLECTING ON THE CALIFORNIA BUSINESS ENVIRONMENT



A special report from Loyola Marymount University's Center for International Business Education.

An economy cannot prosper without a business environment that attracts, retains, and nurtures companies. Therefore, research institutions, including think tanks, trade associations, and business media, periodically publish rankings of each state's business environment. In these rankings, California is consistently ranked lower (e.g., CNBC¹: # 23; Forbes²: # 37) than what might be expected despite the state's economic strength and growth. From 2000 to 2024, California achieved an annual GDP growth rate of 3.22%³, notably higher than the U.S. national growth of 2.55%. This discrepancy warrants revisiting and reflecting on how business environment rankings are determined and interpreted.

Business Environment: A Trade-off Framework

This report uses data from CNBC's rankings⁴ for further analysis based on the following three reasons. First, the CNBC method evaluates the business environment with a comprehensive and representative set of dimensions, including infrastructure, workforce, economy, life, health & inclusion, cost of doing business, technology & innovation, business friendliness, education, access to capital, and cost of living. Second, the ranking system has been established since 2007, enabling a longitudinal analysis of each state's business environment. Lastly, the system relies on objective statistics rather than expert opinions or surveys, thus mitigating potential individual biases.

By applying the principal component analysis algorithm to CNBC's ranking data from 2007 to 2024, we uncover two primary components of the business environment embedded in the original ten dimensions (see Figure 1). The first component is productivity, which is derived from technology and innovation, access to capital, education, workforce, economy, and infrastructure. The second component is affordability, which is heavily influenced by the costs of living and doing business.

This classification of the original business environment dimensions not only reveals the underlying productivity affordability framework but also highlights its inherent trade-offs. On the one hand, productivity drivers, such as education, workforce, and technology and innovation, fall into the opposite side of affordability drivers, such as business friendliness and the cost of doing business. This suggests that it is challenging for a state to simultaneously maintain low taxes and minimal regulation while making substantial investments in education, workforce development, and technology and innovation. On the other hand, the living cost and life quality point to the opposite directions of affordability. While a lower cost of living enhances affordability, it is often associated with a lower evaluation in the life, health, and inclusion dimension, indicating higher crime rates, a less effective healthcare system, and a less inclusive environment. These factors could make it harder for a state to attract a talented workforce and boost productivity.



Which One Should Be Prioritized, Productivity or Affordability?

Using the productivity-affordability framework, we classify the states into four categories based on their productivity and affordability scores. As shown in Figure 2, California stands out as the most productive state by a significant margin.

The trade-off nature of the productivity-affordability framework raises a critical question – which factor has a greater impact on economic growth? To answer this question, we conducted regression analyses of each state's growth in GDP, job, and income on its productivity and affordability scores. The results reveal that productivity has a statistically significant impact on all three growth measures, whereas affordability does not show a significant effect on any of them.



Productivity: A Closer Examination and Comparison

Although productivity's significant influence on economic growth suggests it should be prioritized over affordability, one might still wonder whether a state with relatively lower productivity but much higher affordability offers a better business environment. To explore this question, we compared California with Texas, the two largest state economies in the U.S. They represent the bottom-right and top-right quadrants in Figure 2, respectively. California leads in productivity but has relatively low affordability, while Texas offers high affordability but falls short of California's productivity.



The productivity difference between California and Texas is also reflected in their ratios of GDP share to population share. In 2023, California contributed 14.33% of the U.S. total GDP with 11.63% of the U.S. total population. The ratio of California's GDP share to its population share was 1.23, indicating that California was 23% more productive than the U.S. average. In contrast, Texas had a ratio of 1.01, with 9.11% of the total population and 9.25% of the total GDP⁵. Figure 4 presents the historical trend of productivity of the two states. California's productivity has grown steadily in the past two decades, especially after the 2008 Global Financial Crisis, whereas Texas's productivity has fluctuated within the range of 0.95 to 1.10. productivity has fluctuated within the range from 0.95 to 1.10.



Economic Diversity: A Missing Component in Business Environment

Economic diversity refers to the presence of a broad and balanced mix of industries and businesses within a regional economy rather than reliance on a single sector or a narrow set of industries. It is a critical factor in shaping the business environment, as it creates opportunities for investors with diverse backgrounds and interests, facilitates cross-industry collaboration and innovation, and enhances the stability and resilience of the local economy.

To assess the business environment more comprehensively, we incorporate economic diversity as a complementary component of the productivity affordability framework. Figure 5 and Figure 6 demonstrate the contributions of individual industries to the GDP of California and Texas, respectively. California's economy is more diverse, with a balance of various industries, whereas Texas's economy is dominated by the mining and oil extraction sector.

As for economic stability and resilience, Figure 7 further demonstrates how closely Texas's productivity correlates with fluctuations in U.S. crude oil prices, indicating the sensitivity of its economy to external shocks such as volatility in global energy markets.

Conclusion

Existing approaches to assessing the business environment largely converge on a productivity affordability framework. Our research discovers that productivity, rather than affordability, is much more influential in driving economic growth. Furthermore, we propose that economic diversity be included as a complementary component of the framework to make a more comprehensive analysis of the business environment.









































BRITISH VIRGIN ISLAND FOE JOBS BY SECTOR






