Exporting 101: Pathways to International Markets




California's International Trade by the Numbers


This information was compiled using the most recent trade data from the U.S. Census Bureau.

Fast Facts: June 2022

- ~ California's top five export destinations were Mexico, Canada, China, Japan, and Korea.
- ~ California's share of U.S. exports decreased from 9.0 percent in May to 8.8 percent in June.
- \sim California was the state of destination for 16.0 percent of national imports in June, a slight decrease from 15.4 percent the previous month.

~ Year-over-year export and import volumes continued to increase, with exports increasing by 7.7 percent and imports by 15.1 percent compared to June 2021.
