Fast Facts: July 2022

- ~ California's top five export destinations were Mexico, Canada, China, Japan, and Korea.
- ~ California's share of U.S. exports decreased 5.74 percent from June to July.
- ~ Year-over-year export and import volumes continued to increase, with exports increasing by
- 2.42 percent and imports by 8.96 percent compared to July 2021.
