Local Authority Recommendation Form

This form is to be completed by an authorized representative of a city/municipality, county, special district, regional joint powers authority, council of governments, or tribal government within California. Only census tracts that appear on the official [Qualified Opportunity Zones Eligible Tract list by the U.S. Department of the Treasury \(https://home.treasury.gov/policy-issues/tax-policy/data-transparency/qualified-opportunity-zones\)](https://home.treasury.gov/policy-issues/tax-policy/data-transparency/qualified-opportunity-zones) may be recommended. Shovel-ready sites may also be existing buildings that are ready for substantial improvements. Shovel-ready sites generally include the following factors (sites are **NOT** required to have all factors):

- All utilities (water, sewer, electric power, telecommunications, etc.) are at the site (or within 500ft) or a formal plan must be in place to extend them to the site
- Minimum of 500 kw available electrical service, 3 phase power supply, 480 voltage
- Site must be zoned and fully entitled for headquarters, R&D, and/or industrial manufacturing projects
- Grading completed - soil characteristics disclosed and groundwork completed
- Environmental Impact Report (EIR) or California Environmental Quality Act (CEQA) certified, with no liabilities (soil/cleanup or any other remediation)
